



Completing your Health Risk Questionnaire

To get to the myCigna website, go to <u>www.mycigna.com</u>. As an alternative, you can also download the free <u>myCigna</u> app for your smart phone. New Enrollees will need to "register now" to create an account the first time using the site.

1. Once you log into your mycigna.com account, use the "Wellness" tab at the top of the page and select "My Health Assessment".



2. Click on "Next" on the welcome page. On the next screen, "Agree" to the Privacy Statement

4. Choose "Let's Take a More Traditional Approach." When prompted again, confirm that you'd like to take a more traditional approach.







5. Click on "Let's Do This!" The Personal Information sections asks questions about your personal health, like cholesterol, and blood pressure. You will have the option to update your personal information if you want to (this is not required) and you can re-take the assessment at any time.
