What you pay for a drug depends on which “drug payment stage” you are in when you get the drug.

As shown in the table on the next page, there are “drug payment stages” for your prescription drug coverage under Cigna-HealthSpring Rx (PDP). How much you pay for a drug depends on which of these stages you are in at the time you get a prescription filled or refilled. Keep in mind you are always responsible for the plan’s monthly premium regardless of the drug payment stage.

Deductible Stage Information for Retirees of BorgWarner Peso Salaried (BM3)

During the Deductible Stage, you pay the full cost of your drugs.

You stay in the Deductible Stage until you have paid \$50 for your drugs. The Deductible Stage is the first payment stage for your drug coverage. This stage begins when you fill your first prescription of the year. When you are in this payment stage, you must pay the full cost of your drugs until you reach the plan's deductible amount, which is \$50 for 2020.

- Your "full cost" is usually lower than the normal full price of the drug, since our plan has negotiated lower costs for most drugs.
- The "deductible" is the amount you must pay for your Part D prescription drugs before the plan begins to pay its share. Once you have paid \$50 for your drugs, you leave the Deductible Stage and move on to the next drug payment stage, which is the Initial Coverage Stage.

Additional Benefits offered for Retirees of BorgWarner Peso Salaried (BM3)

Your plan covers additional drugs not normally covered in a Medicare Prescription Drug Plan as indicated in the Formulary Drug List by the + symbol. Please see your 2020 Formulary document for details. The cost share you pay on these drugs do not count toward your annual TrOOP.
